HCA Update

Val Webb gave verbal update on HCA activities. Ms. Webb stated HCA unexpectedly lost \$25,000 in grant funding due to lack of state funds, which put HCA in need of City funding assistance. Ms. Webb requests a one-time \$25,000 allocation to HCA so the HCA Board can revamp the programs and make HCA self-sufficient.

Commissioner Ash stated the City is financially strapped at this point.

Mayor Johnson recommends that Ms. Webb meet with Ms. Mathes and Commissioner Ash to discuss options.

Commissioner Grove stated the HCA Board is really doing great things with the programs.

Budget/Personnel Discussion

Mayor Johnson stated he feels it is time the City look into hiring a City Manager. Mayor Johnson stated an experienced City Manager can bring new ideas, come up with new revenue sources, and led the City in dealing with the many issues we now face. Mayor Johnson stated there is approximately \$17,000 left of Cindy Summerhill's salary, which is enough to bring the City Manager on board by August. Mayor Johnson stated his advisory committee which consists of Augusta West, Jim Bachrach, Tom Morgan, George Mahr, and Bill McCartney have discussed this, and feel this is doable.

Commissioner Ash stated she wants to see a plan or projection before she can make a decision.

Mayor Johnson stated that he wanted to make it clear that this was absolutely no reflection on Ms. Mathes and her abilities as City Administrator. Mayor Johnson continued stating that this will not displace any employee or affect anyone's current salary.

Fire Department Certifications

Commissioner Ash stated she has emailed the college and has not received a response.

Commissioner Grove stated she will contact the Fire College and see what can be found as far as certifications. Commissioner Grove stated the Auxiliary Group has offered to assist with training costs.

Harbor Master Lease - Florida Geotourism

John Alber addressed the Commission regarding Florida Geotourism lease to occupy the Harbor Master House.

Attorney Durrant, attorney for Mike and Robin Vroegop, addressed the Commission and outlined terms of lease.

Discussion held concerning subletting, use of space, and contract terms.

Motion made to take the leases presented on December 14, 2017, March 6, 2018, and April 24, 2018, incorporates languages, sort out differences with the various versions and come back for final approval at May meeting made by Commissioner Bartley, seconded by Commissioner Elliott.
