#### **BRIEF SUMMARY**:

#### Suggested additions to CRA Plan goals:

- (a) The clearance, landscaping, and maintenance of alleys, right of ways, and parks in the Hill neighborhood and other CRA areas.
- (b) The development of workforce housing within the Hill neighborhood, including the sale and acquisition of real property in the Hill neighborhood for workforce housing.
- (c) Commercial building and facade renovations in the Hill neighborhood.
- (d) Replacement and maintenance of street signs and historical signs in the CRA area, and creation of new historical markers.
- (e) Extra trash pickup in downtown business area during holiday weekends and major festivals.

#### Administrative changes to CRA plan

#### 1. Daily Administration

The day to day operations of the Redevelopment Agency shall be run by a volunteer Secretary, named by the City Commission, in coordination with the City Manager and other city staff. The duties of the Secretary shall include:

- 1. Assist City staff and residents on publicity, record keeping, publication of minutes, and Agendas.
- 2. Tracking deadlines for required state reports.
- 3. Assist with building public/private CRA partnerships.
- 4. Other occasional CRA duties and responsibilities requested by the City Manager or members of the Community Redevelopment Board.
