5. Coxwell public records request (Winterringer).

In a November 13 e-mail message, general contractor Glen Coxwell asserted that Mr. Winterringer's and Ms. Stafford's September 24 impromptu encounter with Mr. Coxwell while he was clearing the vacant lot at the corner of 9th Street and Avenue F was a "special meeting" of the Tree Committee under the Florida Sunshine Law (open meetings law), which requires that the public be notified so that they may attend and that meeting minutes be recorded. In the message, he formally requested a copy of the minutes and said, if they are not forwarded to him, he will file a formal records request through City Hall to obtain them.

By e-mail message on November 13, City Clerk Lee Mathes responded to Mr.Coxwell that "There was no special meeting of the Tree Committee on September 24."

By e-mail message on November 18, Mr. Coxwell filed a formal records request to Tree Committee members, city employees, and City Commissioners. He requests that the records be provided to him within 30 days (by December 18).

Documents are to be sent to city attorney Dan Hartman or City Clerk Lee Mathes, who will send them to Mr. Coxwell.

6. <u>Department of Environmental Protection proposal for development in the Orman House</u> botanical garden (Gibson).

Ms. Gibson discussed the proposal for an 1,800 square-foot pavilion and two restrooms totaling 800 square feet. At its November 13 meeting, the Planning and Zoning Board approved the proposal conditioned on the City Commission's subsequent approval. It's anticipated that the proposal will be on the agenda for the next meeting of the City Commission.
