

# CDBG Second Public Hearing Notice

## City of Apalachicola, Florida Second Public Hearing Notice

The City of Apalachicola plans to apply to FloridaCommerce for a FFY 2025 Small Cities Community Development Block Grant (CDBG-SC) of \$362,350 in the Neighborhood Revitalization category. The activities, dollar amounts and estimated percentage benefit to low- and moderate-income persons are as follows:

The City will rehabilitate three drinking water wells, which are currently in poor shape and need to be taken offline frequently for repairs, maintenance, and cleaning. The rehabilitation would include the installation of new preventative maintenance technologies that will allow the City to maintain their wells without taking them completely offline. This project will also reduce long-term operations and maintenance costs for the City. Additionally, this would help to prevent the City from having to place boil water notices for residents serviced by these wells because of the poor conditions of the water wells.

The City of Apalachicola does not expect that anyone will be displaced as a result of CDBG-funded activities. If any persons are displaced as a result of the planned activities, the City of Apalachicola will be adopting an Anti-Displacement and Relocation Policy as a required part of accepting the grant if awarded.

A public hearing to provide citizens an opportunity to comment on the application will be held at 74 6TH Street, on Tuesday April 22 th , 2025, at 1:00 p.m. Persons wanting to submit written comments on the application should send them to Briana Robinson, City Planner, by e-mail at [brobinson@cityofapalachicola.com](mailto:brobinson@cityofapalachicola.com) or by mail to 192 Coach Wagoner Blvd., Apalachicola, FL 32320 no later than April 22th , 2025.
