Hold Harmless & Permit greement

- I understand that I must permanently affix my annual permit to rear lower left window.
- I understand that this permit is not transferable.
- I understand that a permit may not be used to launch more than one craft. Should I wish to launch more than one craft, I will have to purchase another permit.
- I understand that it is MY responsibility to make sure that my annual permit is displayed in my rear lower left window.
- I understand that any parking tickets I receive are MY responsibility and that the City of Apalachicola will NOT void tickets.
- I understand that should I be found guilty of falsifying my application in order to obtain the resident rate for myself or someone else, ALL my permits will be revoked.
- I understand that if I lose my season boating/parking permit, a \$100 service charge will be assessed and must be paid before a replacement is issued.
- I understand that Boat Permits are NON-REFUNDABLE.

The City of Apalachicola assume no liability of or personal injury or damage to said boat or board, or any personal property of the permit owner or others while using launch facilities or while the boat or board is stored at a facility. Permit owner agrees to comply with the provisions of the Code of the City of Apalachicola, laws of the State of Florida and the laws and regulations promulgated by the United States Government. Failure to abide by said rules, regulations and laws shall constitute cause for revocation of their permit(s). The permit owner accepts all the conditions herein imposed and shall be responsible for any person occupying his/her boat/board. This permit is not transferable and shall be void in the event ownership of the boat/board described herein is transferred by the permit owner.

I recognize thatthere are certain risks of physical injury and I agree to assume the full risk ofany injuries, including death, damage Qr loss which I may sustain as a result of participating in any and all activities connected with or associated with the activities.
